Overview	Module 2 of the Professional Land Management Certificate Program is designed to provide the critical skills and knowledge necessary to ensure that the correct owner is leased and that the title is marketable. The course examines the process of chaining titles back to Letters Patent, including the ability to understand and interpret conveyance instruments and ensure that title is marketable by 'curing' defects in the chain of title. Probate laws are examined, and legal calculations are presented.
